IMPORTANT REMINDERS

- Golf bags may be loaded in golf carts.
- Caddies may ride and drive golf carts.
- Distance measuring device may be used. But use of any device (including mobile phones) that measure slope, wind speeds, etc. are strictly prohibited. Penalty for breach of this rule is **DISQUALIFICATION**.
- **DRESS CODE:** Jogging pants, tight pants, biking shorts, leggings, denim pants, tube tops, plunging necklines, see through shirts or blouses are **NOT** permitted in the tournament. Players violating this rule will be asked to change to more appropriate shorts or skirts.
- No gallery will be allowed during the circuit legs.
- Ready golf is highly encouraged.
- "Call-up Hole Rule" is strictly implemented on all Par 3 holes.
